
Act now: Environment of Preshute and Marlborough under threat

The threat ...

- To build **600 houses in Marlborough and Preshute**. There is no evidence to support this number and the impact on congestion, air quality and services would be profound. It is worth noting the recent Marlborough Area Neighbourhood Plan (MANP) allocated land for 65 houses.
- A very large area is allocated to build **houses**, an office development and an industrial estate in Barton Dene in Preshute, a tranquil and quiet dry river valley situated in the North Wessex Area of Outstanding Natural Beauty (AONB) and owned by Marlborough College.

Local Plan consultation is happening now ...

A Local Plan sets out a vision and a framework for the future development of an area. Wiltshire Council are currently consulting on the Local Plan for 2020 to 2038.

Preshute and Marlborough Neighbourhood Plans approved by the community

You may remember that both Preshute Parish Council and Marlborough Town Council have recently produced Neighbourhood Plans (NP) that set out policies to cover planning applications up to 2036. These Neighbourhood Plans were voted on by the local community and approved in February and March this year. Both councils worked closely with Wiltshire Council to ensure their NPs were in alignment with Wiltshire Council's developing draft Local Plan. Initially the Marlborough Area Neighbourhood Plan (MANP) proposed building 245 new homes in Marlborough. Wiltshire Council state on page 17 of MANP, "there is no strategic necessity for 245 open market dwellings" and it goes on to state "Assessed need would be met by a contribution of a minimum of 50 dwellings". (This was provided for by the MANP which allocated land for 65 homes). On the same page it states "The town is not regarded as a sustainable location for growth of any scale and must address its challenges within its environmental constraints." It also states that, "on current evidence, further employment land is not needed at Marlborough". We struggle to understand what has changed to ride roughshod over the views of the community to propose unnecessary development within the AONB. There is no explanation why WC has inexplicably contradicted their own stated strategy by proposing major development which they said in March 2023 were not necessary.

Area of Outstanding Natural Beauty (AONB) has highest level of protection

Marlborough is the only market town in Wiltshire contained within the AONB. The National Policy gives the highest level of protection to the AONB, the same as is given to National Parks. "Development Planning permission should be refused for major developments in these designated areas except in exceptional circumstances and where it can be demonstrated they are in the public interest". There are no exceptional circumstances and there is no public interest to be served in developing Barton Dene.

Impacts of theses major developments

These major developments will have severe impacts on the character of the nationally important AONB, increase congestion, reduce air quality, cause parking problems, place additional burden on services and infrastructure and create a precedent for further degradation of the wider area.
